Test Hours: 7:30 AM to 5:00 PM

Entries close Wednesday, September 20, 2017, after which time entries cannot be accepted, cancelled, altered or substituted except as provided for in Chapter 11, Section 6, of the Dog Show Rules. In accordance with AKC Regulation, Chapter 1, Section 26a, entries in these tracking tests shall be accepted up until the official closing date, even though the limits have been reached.

A drawing from all the entries received will be held at 6:00 PM on Wednesday, September 20, 2017, at the home of the tracking test secretary to determine participants in the tests. When the advertised limit has been drawn, all remaining entries will be similarly drawn and assigned a position on the Alternates list.

Tests will be limited to 3 TD tracks and 3 TDX tracks or a combination thereof.

From the HOST HOTEL (Comfort Inn) take Rt. 395 S approximately 6.3 miles to Exit 91W towards Willimantic/Hartford. Proceed on Route 6 approximately 3 miles to the intersection of Rt. 169 (traffic light). Take a left on Rt. 169 – the Fairgrounds are on the RIGHT.

From the La Quinta (Plainfield) go West on Pratt Rd. turn immediately RIGHT on Lathrop Rd. merge RIGHT onto I-395 North toward Worcester take Exit 32 for CT-14 toward Moosup/Sterling turn RIGHT onto CT-14W 0.6 miles turn RIGHT onto CT-12 N/Putnam Rd. go 1.5 miles turn LEFT onto CT-205N Wauregan Rd. go 3.6 miles – the Fairgrounds are on the LEFT.

From THE INN AT WOODSTOCK HILL: go North on Plaine Hill Rd. turn immediately RIGHT onto CT-169S Norwich Worcester Turnpike 1.1 miles turn RIGHT on 169S 5.9 miles turn RIGHT on CT-169S take an immediate RIGHT onto Fairgrounds Rd. the Fairgrounds are on the RIGHT.

Acknowledgments

Entries drawn to participate and all Alternates will be notified by email as soon as possible following the draw. For each test priority will be given to dogs without a title at that level. Alternates who are present at the test site at the time of drawing for tracks may replace any absent dogs. Entry fees of alternates who do not participate will be returned in full within 7 days following the test. Entry fees of participants who cancel after the closing date but prior to the test date will be refunded if a participant from the Alternates list takes their place. Per AKC regulations, if either the TD or TDX test does not fill, space may be opened in the other test for additional dogs to compete. Entrants will be notified of such changes.

Drawing for TD tracks will take place at 8AM at the test headquarters and drawing for TDX tracks will take place at 10 AM at the same location.

RULES AND REGULATIONS

1. LRC, Inc. Will exercise all reasonable care for the safety of dogs and handlers competing, but will not be responsible for loss or damage or injury to any dog or handler or property.
2. Owners or agents entering dogs in a tracking test do so at their own risk.
3. Dogs must be kept on leash at all times.
4. Bitches in season may compete subject to the provisions in Chapter 2, Section 8 of the AKC Tracking Regulations, but must run the last track. Please leave bitches in season in your vehicle and notify the Tracking Test Secretary on your arrival.
5. Only dogs entered in these tests are allowed on the grounds.

DRAW

All confirmed TD entrants must be at the by 8:00 AM and all confirmed TDX dogs must be there by 10:00 AM to draw for tracks. In each case, the first tracks will be run as soon as they are appropriately aged. In the event of any absences among confirmed entries, the next alternate, in catalog order, who is present, will be allowed to fill the vacancy. Alternates not present who would have been selected will forfeit their entry fees if the track is not used.
